This order shall dispose of the First Appeal No.002/2025 u/s 19(1) of the RTIA,2005.

The Appellant was present in person. The Respondent, the PIO, was present in person. The concerned or supposed custodians in the office of the sought for information, the Head Clerk, the Administrative Bursar, the Accountant & the Accounts Bursar were present in the Hearings in person.

On perusal of records it was observed that –

01.The appellant Sri Bidyadhar Praharaj, Ex-Reader in Economics, along-with his wife Mrs. Sabitri Samantaray, Ex-Senior Lecturer in Odia in the college remained absent in the college unauthorised, without any application or information, w.e.f date 21.07.2008 F.N., were sent to judicial custody on charges of **Murder** on date 18.09.2008 and, consequently put under suspension immediately. Since then, they had not come back on their duties till their retirement from services, retrenchment / dismissal in case of Mrs. Sabitri Samantray and, the suspension order in respect of them had not been revoked. Since long, the appellant had been applying, *inter alia*, for sanction of Earned Leave / Medical Leave in his / their favour for the period from date 21.07.2008 to 17.09.2008, the latest one being his application dated 17.05.2025 and, the successive Principals (Head of the office) of the college had requested clarifications on different points of the same applications of the appellant from the Government in the Department of Higher Education, Odisha but, no response / feedback from that end had been received in the college office.

02. The applicant, appellant in the instant appeal, in applying for information, had put a series of questions.

03. The PIO had provided the sought for information as he could become able to collect or trace in stipulated time.

Heard the Appellant and the Respondent, also, the concerned custodians of the sought for information:-

The Appellant persistently claimed and demanded for sanction of Earned Leave/ Medical Leave with Leave Salary in his/their favour as per his application/appeal for the period from 21.07.2008 to 17.09.2008. he vehemently went on asking : **when the college authority would sanction the said leave with salary.**

The Respondent, the PIO in the office, submitted that the applicant, appellant in the instant appeal, had put a series of questions in his concerned application and, the matter concerning the issues of the appellant were found spread over numerous files in the office. He submitted that as the sought for information in the application were in form of questions, he had provided the information as he could become able to trace and collect in the office system within stipulated time period relevant to the questions of the applicant in his application.

In view of the above, the following order is passed:-

Necessary actions on the instant appeal shall be taken only after getting requested clarifications from the Government in the Department in the Higher Education, Odisha.

The appeal is disposed of accordingly.

Copy of this order be communicated to the Appellant in his suggested address in Registered Speed Post free of cost, and to the PIO, the APIO, the Head Clerk, the Administrative Bursar, the Accountant and the Accounts Bursar in the Office Peon Book.
