- 1. All the resolutions taken by the Governing Body in its previous meeting on dated 06.08.2022 were read out and confirmed unanimously.

- After threadbare discussion on the successor of the incumbent Principal-in-charge it was unanimously resolved to request the Higher Education Department to post a senior reader having academic excellence and administrative experience to remain in charge of Principal. The person to be posted should not have worked in this college previously and should not belong to Jajpur district.
- The report of sub-committee was discussed in detail. The 3. Governing Body accepted the report in principle and directed the Principal to take necessary follow up action in the matter with the approval of the President.
- The matter relating to recovery of the travel grant and initiation of disciplinary proceeding against smt. Pramodini Chakra, Ex-Lecturer was discussed. The Hon'ble High court in W.P(c). No.18863/2022 Pramodini Chakra-vrs-Under Secretary, University Grants Commission and others has been disposed of on 19.9.2022. She has submitted one reply requesting to supply some records. Principal is directed to furnish the available documents to Smt. Chakra immediately and take necessary follow-up action in the matter.
- The order and judgement of Hon'ble High court in W.P.(c) no 5 3908/2022 filed by Ramesh Chandra Samal, Reader in commerce was placed in the meeting. After detail discussion it was resolved to file an appeal before the division bench against the order of the single bench. The principal is authorised to engage another advocate of the Odisha High court inplace of the present advocate.
