
The resolution of the Governing Body is given as follows.

1. Honorable M.L.A, Korai attended the meeting as a special invitee held on date 09.09.2023. At the outset the members expressed serious displeasure over the functioning of college administration during the last few months. The President mentioned that the Principal has been repeatedly violating the written instructions and running the administration at his sweet will. He is not staying at the Headquarters and is remaining at 20 km away from the college. The recent incident where the outsider entered the Boys' Hostel and attacked the students was discussed. It was the serious laps on the part of Principal on the fateful night when which mobile was switched off. The warden did not respond the telephone calls.
2. The various decisions of the Governing Body is not carried out by the Principal. It shows insubordination, disobedience of order and willful negligence on the part of Principal. So the committee recommends for suspension of Principal for the larger interest of students and the institution.
3. The Govt. in Higher Education Department is requested to place the service of a senior Reader as Principal of the College, since the committee does not find any suitable person for the post of Principal. The next senior faculty member shall be in charge of Principal till the appointment of Principal by Higher Education Department.
4. The college is running with shortage of staff in different subjects. The G.B resolved to request the Higher Education Department, Govt. of Odisha to appoint Lecturers in different Departments.
5. The G.B expressed deep concerned of deteriorating law and order in the college/premises. So the Superintended of Police, Jajpur is requested to take exemplary action against the culprits.
6. The tender for procurements of various items should be cancelled since there is lack of clarity in specifications. Fresh tenders shall be invited following proper procedure and with proper specifications. However, the tender for Net connection can be finalized as per the exiting tender. In future while inviting tender, two bids (SMD/Performance guaranty) should be introduced.
